Dear Secretary,

SUBSCRIPTIONS 2019

- Enclosed herewith is the Subscription form for 2019, which is due on **1 January**. Please ensure that your remittance is received by me as soon as possible but **NOT LATER** than **20 January**. Because of the very tight schedule to send the premiums to the Insurance Company, **if the Subscription and Insurance premium is not received by 20th January a handling fee of £20 will be due to cover additional costs.** **(I shall NOT be making telephone reminders)**
- I know you will be pleased to see that the Basic Club Subscription and Members per capita Subscription has not increased yet again this year. This is in recognition of the fact that by using email to forward information to Clubs/Societies - savings continue to be made.
- As the new data Protection Laws (GDPR) require us to review decisions regularly, the EAF have decided for ease of administration, to deal with this at the same time as the Annual Subscription renewal. **Form enclosed for signature and return with the Subscription Payment please.**
- **In order for Clubs to be eligible for insurance cover under the PAGB arranged policies the following definition has been agreed:-**
 - *"A camera club, photographic society, photographic club or photographic group with a published constitution and a published programme of events, united by a common interest in photography, meeting in person for mutual cooperation, education, entertainment or competition and conducted solely from a physical location within Great Britain, Northern Ireland, the Channel Islands or the Isle of Man"*
 - **You are therefore also required to certify on the Subscription form that your Club/Society has a "published" constitution – i.e. a document showing the principles on which the Club/Society is governed - that can be printed and issued to Members or others on request**
- **As a Federation we require all Clubs to be covered for Public Liability Insurance – although it is not compulsory for that cover to be taken via the PAGB Arranged Block Scheme.**

Bearing in mind the generosity of the courts these days, RSA Insurance Company, who provide our PAGB arranged Public Liability cover, have again decided that the sum insured for ALL Clubs MUST be £5,000,000.

Your Annual Subscription to the PAGB also includes **Trustee Indemnity Insurance** cover for your Club (for full details of this insurance please see the EAF Website – insurance Page).

PLEASE NOTE - The insurers again need a certificate confirming that as at the date of completion of the Subscription form, you are not aware of any circumstances which might give rise to a claim against the PAGB – (which includes the EAF and Member Clubs), or any of its officers in respect of Trustee Indemnity Insurance Cover. Please Ensure this certificate on the renewal form is also signed. If you are aware of any potential problems and therefore cannot complete the certificate, please let me know immediately.
